

## **98.9 KPNW Chateau Ste. Michelle Tap the App Sweepstakes Official Rules.**

**NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.**

**1. Eligibility:** The 98.9 KPNW Chateau Ste. Michelle Tap the App Sweepstakes (the "Sweepstakes") is open to listeners 18 years or older and residents of Washington and Oregon.
