Official Rules

1. Eligibility: 98.9 KPNW PNW Road Trip Sweepstakes (the "Sweepstakes") is open to listeners 18 years or older and residents of Washington and Oregon State. Void where prohibited by law. No purchase necessary to enter the Sweepstakes. Employees of Hubbard Radio Seattle, LLC and its station 98.9 KPNW, 3650 131st Avenue S.E., Suite 550, Bellevue, Washington, 98006 ("Sponsor"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor and Promotional Participant, the "Released Parties") any radio, television or other media companies located in the Seattle area, and their immediate family, and their immediate family (spouse, parents, and stepparents, siblings and stepsiblings, and children and stepchildren) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. Sweepstakes Period: The Sweepstakes begins around 8:10:00 AM Pacific Time ("PT") on March 4th, 2024, and ends at 4:59:59 PM PT on March 10th, 2024 (the "Sweepstakes Period").

3. How to Enter: To enter online sweepstakes and contests, listeners must register online at 98.9 KPNW. If entries are permitted by other means, the other permitted forms of entry will be indicated on our website and may periodically be included in on-air promotions. To enter log on to the 98.9 KPNW app or website daily to enter the Words that Win up to 5 times per day during the sweepstakes period. Listener must be a registered user to enter.

4. How to Become the Grand Prize Winner: On March 11th, 2024, Sponsor will randomly select one (1) Grand Prize winner. Odds of becoming the Grand Prize winner depend on the number of eligible entries received during the Sweepstakes Period. Sponsor will contact the potential winner by telephone, email or push notification on the date of the random drawing. In the event Sponsor is unable to reach a potential winner after two (2) attempts, that potential Grand Prize winner forfeits his or her right to the Grand Prize, and an alternate may be selected, time permitting.

5. Prizes and Approximate Retail Values ("ARVs") – One (1) Grand Prize – 2 lower bowl tickets to Kacey Musgraves at Climate Pledge Arena. AVR of \$300. Tickets cannot be sold on eBay, Craigslist or other third party site. The prize is non-assignable and non-transferable and not redeemable for cash. Sponsor may substitute the prize for one of equal or greater value for any or no reason. Winner is solely responsible for paying all applicable income taxes associated with accepting their Prize. The winners must meet the eligibility requirements as set forth in Paragraph 1 of these Official Rules.

6. Claiming the Prize: Upon winner verification, as a condition of being named the official Grand Prize winner, the potential winner must claim his/her prize within 30 days of winner verification. Failure to comply with any deadline set forth in these official rules shall be deemed to be the winner's forfeiture of his or her right to claim the Grand Prize. Participation Conditions/Release/Consent to use Likeness: By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

8. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of

the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prize described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Limitations of Liability: The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited, to malfunctions, interruptions or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.
